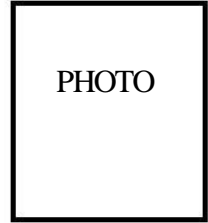

PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Travelorg India , their agents, owners, officers, volunteers, participants, employees, associates and all other persons or entities acting in capacity on their behalf (hereinafter collectively referred to as "Travelorg"), I hereby agree to release, indemnify, and discharge Travelorg , on behalf of myself, my spouse, my children, my parents, my heirs, next of kin, assigns, personal representative and estate as follows:

1. I acknowledge that the pilgrimage tour to Mount Kailash Mansarovar entails known and unanticipated risks that could result in damage to my property, loss of my property, any injury to my person or my death or any damage or injury to third parties or any one or more of the foregoing, arising directly or indirectly out of my participation for any purpose in the pilgrimage tour. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the tour. I expressly agree and promise to accept and assume all of the risks existing in this tour. My participation in this tour is purely voluntary, and I elect to participate in spite of the risks. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Travelorg from any and all claims, liabilities, damages, demands, or causes of action, which are in any way connected with my participation in this tour or my use of Travelorg's equipment or facilities, including any such claims which allege negligent acts or omissions of Travelorg India. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in the tour, or that I will secure such coverage if I do not already have it, or else to bear the costs of such injury or damage, myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have. I understand that Travelorg does not provide such coverage, and that no insurance coverage may exist through Travelorg to cover any injuries or damages which I may sustain or claims which may arise as a result of my participation in the tour. Travelorg nor any of its representatives shall be liable for any loss, injury or damage to you or your belongings or otherwise in connection with any accommodations, transportations or other services or resulting directly or indirectly from any occurrences beyond its control including breakdown in equipment, strikes, theft, or cancellation of or changes in itinerary, or schedules due to unavoidable circumstances including but not limited to government restrictions, landslides, road blockages, flooding, snowfall, political delays or cancellations of flights and helicopters, etc. I further understand that additional costs arising out of such circumstances will be fully borne by me. Each provision of this Release and Indemnity Agreement is severable and if one portion is invalid or illegal, such invalid or illegal portion shall not apply, but the remaining portions shall nevertheless remain in full force and effect.
6. I understand that the terms of the Release and Indemnity Agreement are contractual and not mere recitals, and that such terms are binding upon me, my heirs, personal representatives and assigns. In making this Release and Indemnity Agreement, I have not relied upon any statement or representation pertaining to this matter made by Travelorg or any other person or entity which is hereby released.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Travelorg on the basis of any claim from which I have released herein. I warrant that I have carefully read this document and know its contents, and that I am 18 years of age or older and have full authority to execute this document voluntarily and as my own free act. I execute this document fully intending to be bound by its terms.

RULES AND REGULATIONS

BOOKING

- Photocopy of passport along with \$500.00 (non-refundable) advance deposit.
- Balance amount shall be paid 30 days before departure date.
- Failure to pay before 30 days of departure date will result in a cancellation and cancellation rules will apply.
- Booking is non-transferable and will be considered as a cancellation.

CANCELLATION

- Any and all cancellation will be accepted in writing only at our office at Mumbai - India & Texas - USA.
- Before 30 days of departure of tour 25% of tour cost will be deducted.
- Between 30 days to 15 days of departure of tour 50% of tour cost will be deducted.
- Before 15 days of departure of tour 100% of tour cost will deducted.

OTHER RULES AND REGULATIONS

- "Travelorg India" reserves the right to refuse a booking or to terminate a passenger on tour in the event of unreasonable behavior / misbehavior at any time.
- The tour participant will have to strictly follow the tour program.
- A single person travelling alone has to pay single occupancy charges if a suitable partner for Double/Triple sharing is not available.
